Sec. 1. CHILD FIND PRIVATE SCHOOL STUDENTS

WINFREE ACADEMY CHARTER SCHOOLS shall coordinate with home school districts, who are primarily responsible for consulting with private school representatives, regarding the child find process and the provision of special education and related services to children enrolled in private schools within WINFREE ACADEMY CHARTER SCHOOLS's boundaries.

WINFREE ACADEMY CHARTER SCHOOLS shall undertake activities similar to those undertaken for children enrolled in public schools and shall complete the child find process for children enrolled in private schools in a time period comparable to that for other students attending the public schools within WINFREE ACADEMY CHARTER SCHOOLS's boundaries.

20 U.S.C. 1412(a)(10)(A)(ii)–(iv).

Sec. 2. SPECIAL EDUCATION STUDENTS PLACED IN PRIVATE SCHOOL

a) Placement by WINFREE ACADEMY CHARTER SCHOOLS

If WINFREE ACADEMY CHARTER SCHOOLS places a child with a disability in a private school or facility, or refers the child to a private school or facility, as a means of carrying out the requirements of the special education laws, WINFREE ACADEMY CHARTER SCHOOLS shall ensure that the child is provided special education and related services, in accordance with an individualized education program ("IEP"), at no cost to the parents.

20 U.S.C. 1412(a)(10)(B)(i).

b) Placement by the Parent

When a student with a disability who has been placed by his or her parent directly in a private school is referred to WINFREE ACADEMY CHARTER SCHOOLS, WINFREE ACADEMY CHARTER SCHOOLS shall convene an admission, review, and dismissal ("ARD") committee to determine whether WINFREE ACADEMY CHARTER SCHOOLS can offer the child a free appropriate public education ("FAPE"). If WINFREE ACADEMY CHARTER SCHOOLS determines that it can offer a FAPE to the student, WINFREE ACADEMY CHARTER SCHOOLS is not responsible for providing educational services to the student, except as provided in 34 CFR 300.130-300.144 or 19 TAC 89.1096(e), until such time as the parents choose to enroll the student in WINFREE ACADEMY CHARTER SCHOOLS full time.

Sec. 3. <u>REJECTION OF OFFER OF FAPE</u>

a) Student Receives ISP

If WINFREE ACADEMY CHARTER SCHOOLS offers to provide a FAPE to a child with a disability and the parents elect to place the child in a private school or facility, WINFREE ACADEMY CHARTER SCHOOLS is not required to pay for the cost of education, including special education and related services. However, WINFREE ACADEMY CHARTER SCHOOLS must develop and implement an individualized services plan ("ISP") for the child.

20 U.S.C. 1412(a)(10)(C)(i); 34 CFR 300.148(a).

b) Reimbursement

If the parents of a child with a disability, who previously received special education and related services under the authority of WINFREE ACADEMY CHARTER SCHOOLS, enroll the child in a private school without the consent or referral by WINFREE ACADEMY CHARTER SCHOOLS, a court or a hearing officer may require WINFREE ACADEMY CHARTER SCHOOLS to reimburse the parents for the cost of that enrollment if the court or hearing officer finds that WINFREE ACADEMY CHARTER SCHOOLS had not made a FAPE available to the child in a timely manner before the enrollment.
